RE: **BASEBALL B.C. ASSOCIATE MEMBER INSURANCE PROGRAM APPLICATION**

Baseball is upon us, and it is time to begin preparing for the upcoming 2024 season. With that, we are pleased to announce that Baseball B.C. will be offering insurance coverage this year again to all Baseball BC Members currently in good standing. As a member Baseball BC, you will be considered an Associate Member and as such are entitled to access all the programs and services offered to every member with no additional charge or requirement for you to consider.

As per Baseball BC's Membership policy, all players and coaches participating in this Membership Insurance Program will be assessed a \$9.00 Insurance fee with free coverage for executives & volunteers for their services. Please note that Membership & the policy commence April 1st and conclude March 31st every year, and therefore, a new application & registration sheet must be submitted for each season. To avoid challenges or denial to any claim, applications, payments, and accurate registration data for all member participants must be provided before baseball activities begin and consequently before any claim can be accepted; moreover, the previous can hold true for all other member benefits as well.

As mentioned, & consistent with previous years, all Associate Members will need to complete the Associate Member Application to be included in the Baseball BC Insurance Program for 2024. We are asking that this process be completed by March 28th. (Memo's, including Application Form(s) in Word & pdf, and Excel Registration Template are attached).

Your association can be added to the policy at any time but should be reminded that any liability coverage would cease to exist April 1st should you choose to simply wait. It is our recommendation that you do not allow this to occur so that you can ensure appropriate coverage for all, including directors and volunteers throughout the year.

Approved Associate Memberships will be granted some flexibility with the reconciliation of registered player data and membership fees through Spring to allow those details to be finalized. Please do not worry about these requirements while navigating possible uncertainty. And member information is guarded by strict policy & confidentiality.

MEMBERSHIP & INURANCE PROGRAM

Accident & Liability Insurance (*world-wide coverage*)

Coverage includes the following benefits for a one-year period, commencing April 1st each year:

1. General Liability

- a) Limit - **\$5,000,000** each occurrence
- c) Insured - B.C. Amateur Baseball Association and affiliated clubs/leagues
- d) Additional Insureds - Officers, Directors, Coaches, Managers, Officials, Members, Volunteers & Employees
- e) Sponsors, Government Departments & Municipalities can be added as Additional Insureds at no extra cost
- f) Participant coverage is included
- g) All appropriate riders included, such as Cross Liability, Non-Owned Automobile, Tenants Legal, etc.

Directors & Officers Liability (Wrongful Acts/Errors & Omissions) is included in the program. Limit - \$2,000,000 (Includes both Provincial & Club Directors)

This coverage protects the Director's & Officer's from potential errors and omissions claims arising from the following areas:

- Discrimination (age, race or sex)
- Suspension of Coaches
- Acts beyond granted authority
- Financial Decline
- Insufficient administration or supervision resulting in losses
- Waste of Association assets
- False or misleading reports
- Failure to deliver services
- Causing the Association to incur unnecessary tax liabilities
