Re: CCBC Member Insurance Renewal – Please forward to your association's/team's correct contact.

Baseball is upon us, and it is time to begin preparing for the upcoming 2024 season. With that, we are pleased to announce that Baseball B.C. will be offering insurance coverage this year again to all Baseball BC Members currently in good standing. As a member Baseball BC, you will be considered an Associate Member and as such are entitled to access all the programs and services offered to every member with no additional charge or requirement for you to consider.

All CCBC Teams/Associations participating in Baseball BC's Associate Membership Program will be assessed a \$500.00 Insurance & Liability fee, though, we provide free coverage for executive & volunteers for their services. Please note that Membership & the Insurance policy commence April 1st and conclude March 31st every year, and therefore, an updated application & member information sheet requesting affiliation must be submitted each & every season. To avoid challenges or denial to claims, member benefits, etc., applications, payments and accurate registration data for all member participants must be provided by the partnering league or association before baseball activities begin and consequently before any claim can be accepted. Please note that strict confidentiality and policies will be in affect with all submitted member information.

As mentioned, & consistent with previous years, all CCBC Members will need to complete the Associate Member Application, Member Data sheet, and payment to be included in the Baseball BC Insurance Program for 2024. We are asking that this process be completed by March 31st. (Memo's, including Application Form(s) in Word & pdf, and Excel Registration Template are attached).

Your association/team can be added to the policy at any time but should be reminded that any liability coverage would cease to exist April 1st should you choose to simply wait. It is our recommendation that you do not allow this to occur so that you can ensure appropriate coverage for all, including directors and volunteers throughout the year.

Approved CCBC Associate Memberships will be granted some flexibility with the reconciliation of registered player data and membership fees through Spring to allow those details to be finalized. Please do not worry about these requirements while navigating possible uncertainty. And member information is guarded by strict policy & confidentiality.
